Liquidity continues to increase

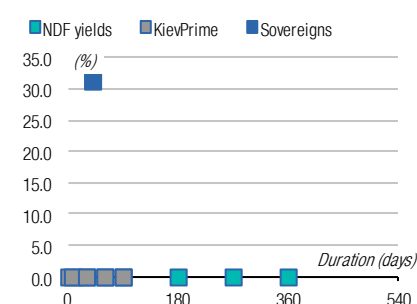
Banking sector liquidity rose a significant UAH2.99bn to UAH84.29bn yesterday, the record high since August 2016, mostly due to large inflows. The NBU purchased new portion of FX and injected UAH0.77bn into liquidity, while the MoF paid a UAH1.5bn VAT refund. With accelerated budget expenditures expected, the budget also received the approved UAH10.0bn tranche from the NBU and UAH6.4bn in tax payments on Tuesday. With these inflows, banks' correspondent accounts with the NBU rose UAH0.49bn to UAH41.67bn and total CDs outstanding was up UAH2.50bn to UAH41.62bn, the largest amount since September 2016.

Investment implications: According to the Treasury, only UAH1.50bn of the refund was paid on Wednesday while the total amount documented for refund was UAH3.96bn (and probably was paid yesterday). Also, the NBU once more purchased US\$30m of FX at the auction, injecting UAH0.77bn. With so many sources to increase liquidity, only tax payments put the usual pressure on liquidity. Meanwhile, Privatbank paid UAH1.6bn of loans to the NBU, which withdrew from liquidity. While we do not anticipate liquidity to decline today, any increase is not expected to be as significant as it was yesterday.

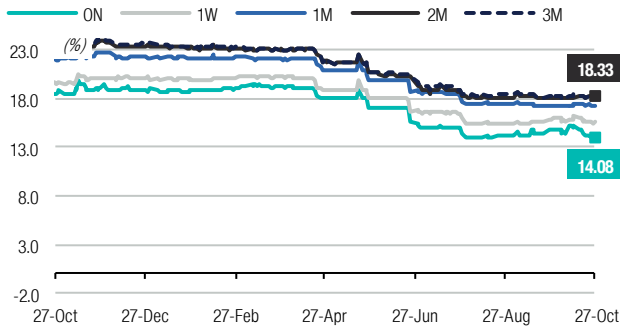

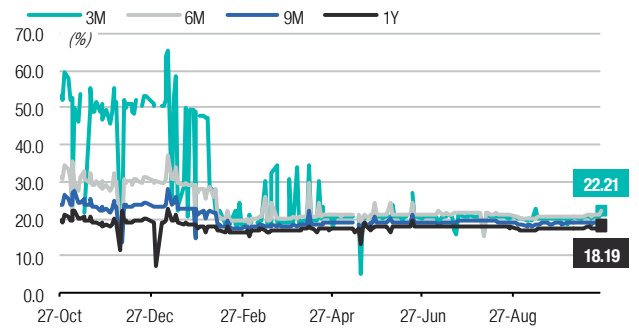

Chart 1. Kiev Prime rates (%), last 12-month period



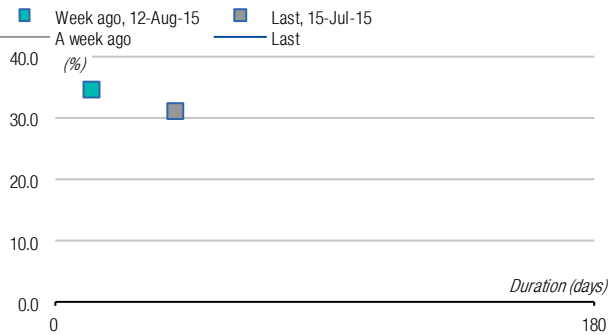

Chart 2. UAH NDF implied yields (%), last 12-month period



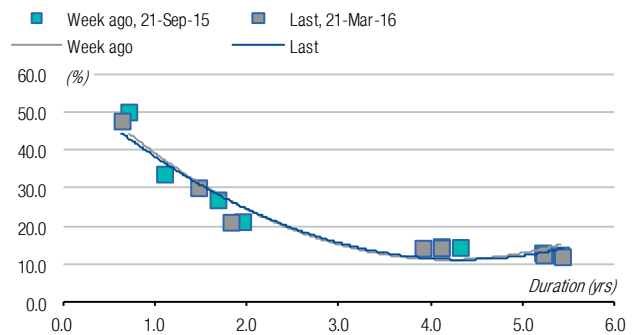

Chart 3. UAH sovereign yield curve (%) as of 27 Oct 2016



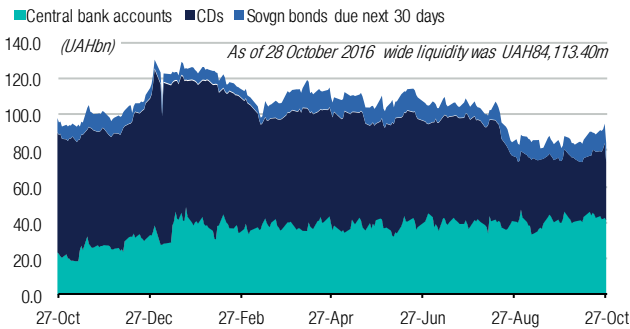

Chart 4. USD sovereign yield curve (%) as of 27 Oct 2016



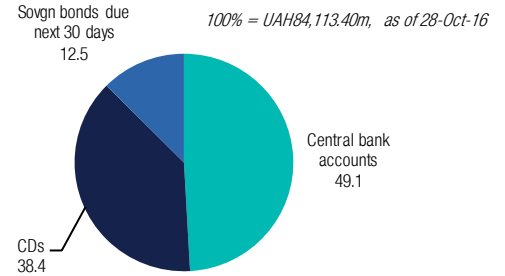

Chart 5. Banking sector liquidity (UAHbn), last 12-month period



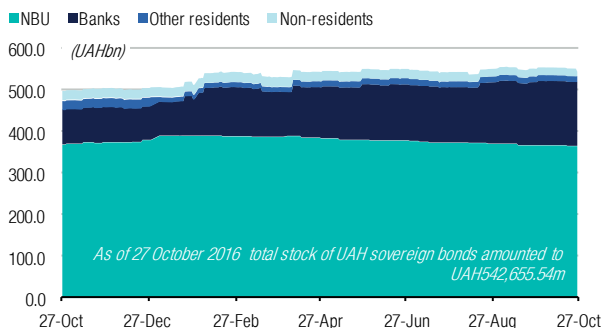

Chart 6. Breakdown of liquidity pool (%) as of 27 Oct 2016



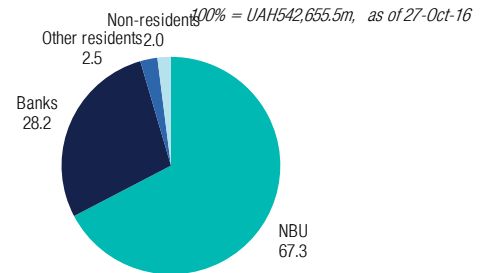

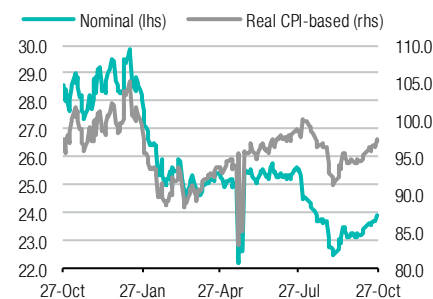

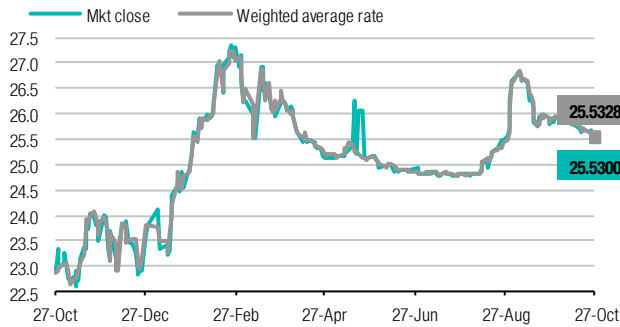

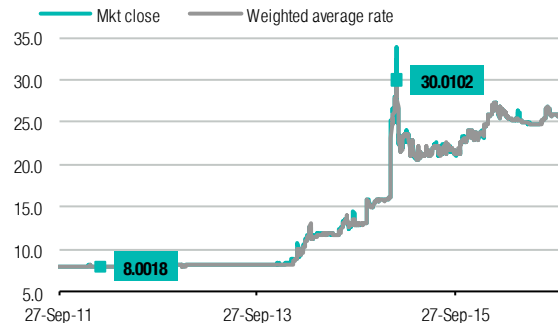

Chart 9. Spot market rates USD/UAH: last 12-month and 5-year periods (UAH per USD, left and right respectively)

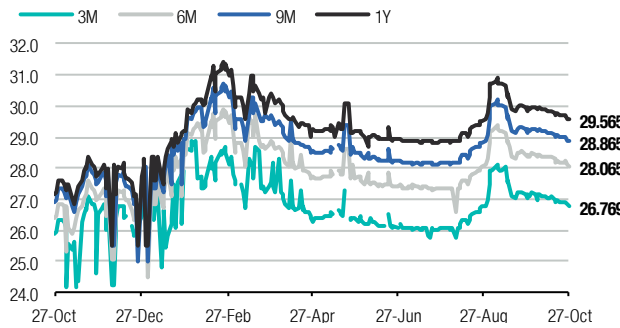

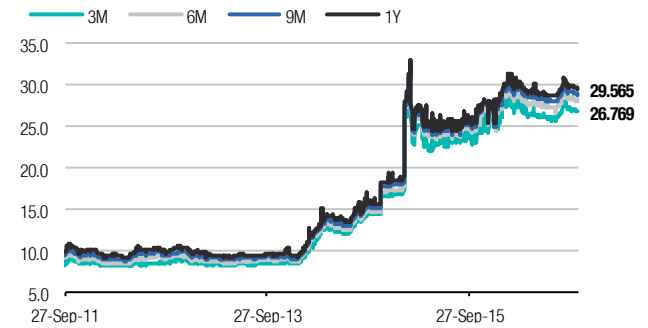

Chart 10. NDF market rates USD/UAH: last 12-month and 5-year periods (UAH per USD, left and right respectively)

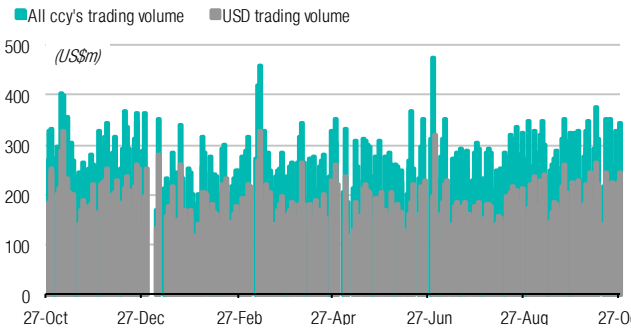

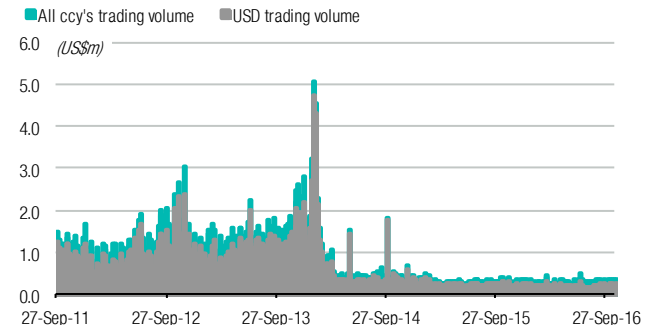

Chart 11. Trading volume: last 12-month and 5-year periods (US\$m, left and right respectively)

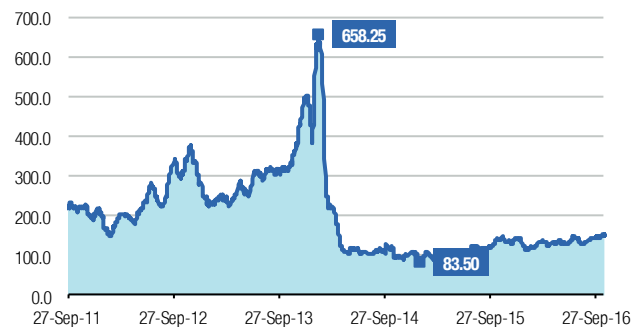
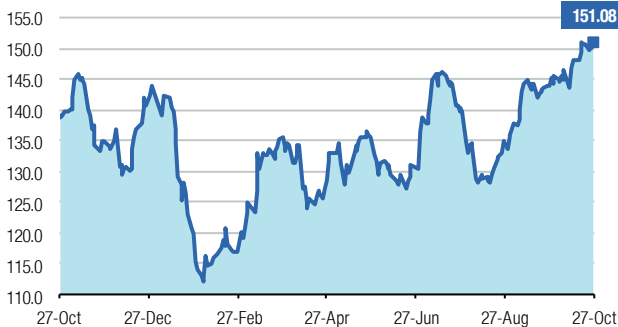

Chart 12. 30D MA* ratio of FX market turnover to merchandise trade: last 12m and 5yr periods (% , left and right respectively)

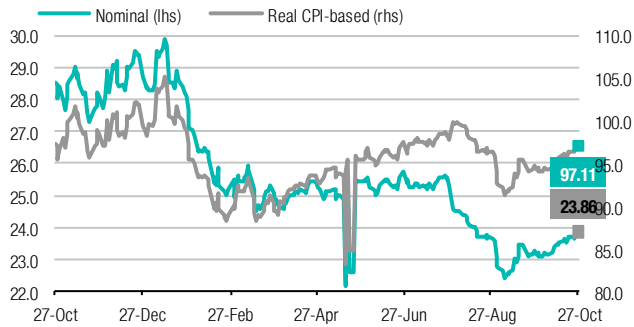

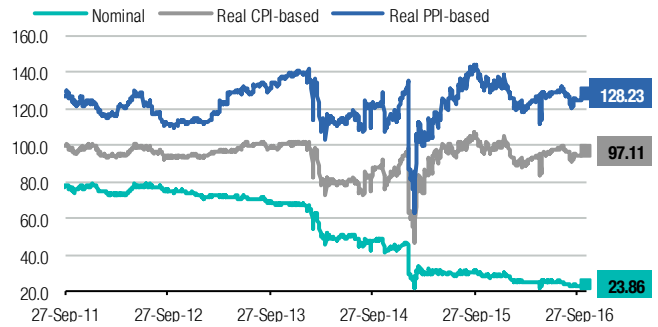

Chart 13. Nominal and CPI-based real TWIs of UAH, history of last 12-month period



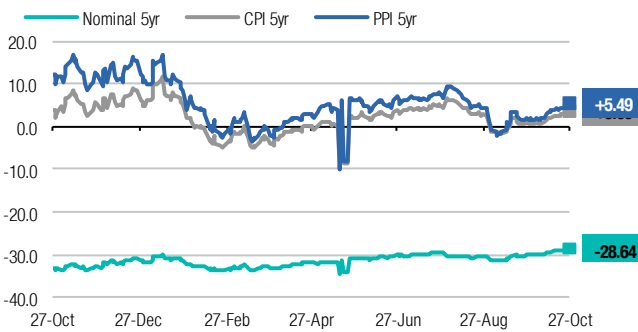

Chart 14. Nominal, CPI- and PPI-based TWIs of UAH, history of last 5-year period

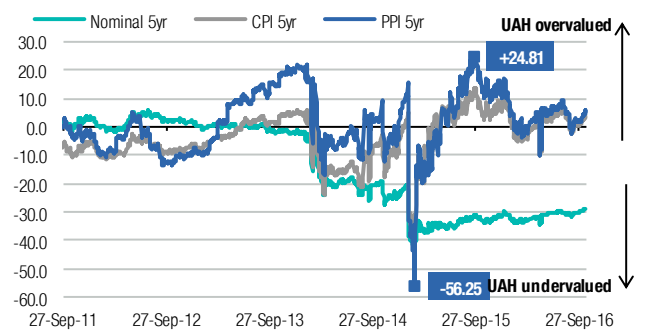

Chart 15. Deviation of UAH trade-weighted indices from their 5-year moving averages: last 12-month and 5-year periods (% , left and right respectively)

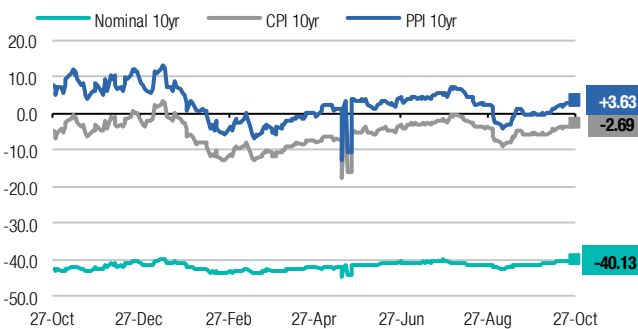

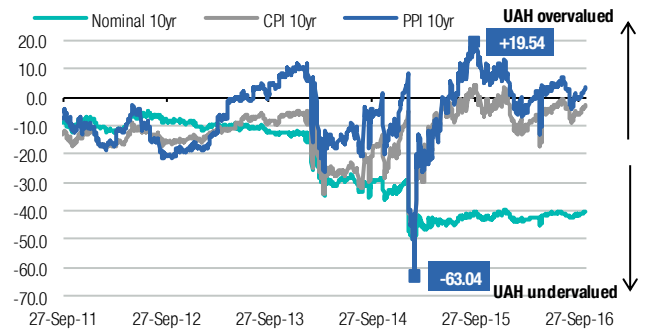
